JOB PURPOSE

To lead, develop and manage the physical production of The Marlowe Theatre's work, providing planning and physical support and to develop and operationally manage the theatre's production facility and rehearsal rooms at the Sidney Cooper Studios.

PRINCIPAL ACCOUNTABILITIES

- To manage the physical production output of The Marlowe Theatre, ensuring the
 delivery of all production budgets, planning and physical support for Marlowe
 Theatre productions, co-productions and the learning and participation
 programme, in order to deliver the theatre's artistic and business objectives to
 the highest possible standards.
- Working alongside the Executive Producer, to advise the Marlowe Theatre Executive on the development of a business model for the theatre's rehearsal and production and rehearsal facility at the Sidney Cooper Studios
- To deliver the agreed business model, pro-actively developing a new client base across regional and national technical production partners within both the subsidised and commercial sectors.
- To provide a welcoming and positive environment to creatives and production personnel and exemplary leadership to all those who work within the Marlowe Productions team
- Working closely with the Marlowe Technical Manager, lead teams of Marlowe staff and freelancers to manage the safe and effective construction, installation and facilitation of Marlowe Theatre productions, to deliver high quality outcomes.
- Working closely with The Marlowe Executive Producer and team, ensure that all productions are budgeted and scheduled accurately in order to ensure productions are achieved within agreed budget and timescale parameters.

- To manage the day to day operation of the Sidney Cooper Studios, ensuring H&S compliance on all Marlowe production work, including staff training, production of all RAMS and oversight of production and stage CDM briefings, and compliance with the Marlowe Trust's Health and Safety Policy.
- Fulfil or, subject to agreement, delegate, the role of Production Manager for each production, ensuring the teams work in a safe and legal way to comply with regulatory and legislative requirements and industry best practice both in production and whilst onstage.
- To support the Director of Technical and Building Services in ensuring that the theatre's workshops, production and rehearsal facilities are appropriately equipped and stocked and that the equipment complies with all statutory requirements.
- To inform the Director of Technical and Building Services and the Chief Operating Officer of any additional risk.
