We may use images and video for The Marlowe's fundraising activity, including sharing with The Marlowe's sponsors for reporting on activity funded by them.

Images and video may be used for press coverage and in non-Marlowe print or online platforms.

Images and videos of young people are recorded on company devices (never the personal devices of staff or workshop leaders) or by vetted professionals, and stored on The Marlowe's secure image database in a GDPR safe folder. Children's identities will not be disclosed without consent.

If you do not give permission for your child to be photographed, filmed, surveyed or interviewed, we will arrange in advance to ensure, in a discreet way, that your child is not included in any content captured.
